# GAMBLING

#### The Betting Houses, Gaming Houses and Prevention of Gambling Law

- General Prohibition on betting and gambling (games of chance/ combined chance and skill):
  - $\circ$  slot machines
  - $\circ$  dice gambling
  - $\circ$  roulette
  - $\circ$  casino games
  - use of premises for betting and gambling



# GAMBLING

#### **Regulated**

- "Kazanti": Cypriot traditional pinball type game of chance used at local fairs
- License issued by the District Administrator subject to conditions



# GAMING

#### The Gaming Machines, Skill Machines and Entertainment Machines Law of 1996

#### PROHIBITED

- Slot Machines
   <u>REGULATED</u>
- Skill Machines
- Game Machine
- Entertainment Machine



#### Licence (National Betting Authority)

- <u>Types of Licences</u>
- Class A: Physical (Licensed Premises)
- Class B: Electronic (Online)
- License Subjects
- Bookmaker (Class A or B)
- Authorised Representative (Class A)
- Premises (Class A)



#### License Application for Bookmakers and Authorised Representatives

- Payment of Fee
- Submission of Form
- Proof that the Applicant:
  - Has not been convicted of a relevant offence
  - is 18 years old



#### License Application for Bookmakers and Authorised Representatives

- Class B:
  - Application by company limited by shares, incorporated in the Republic or outside the Republic:
  - o main activity: managing bets
  - issued and paid-up share capital is at least EUR 500.000
- Bank guarantee from credit institution for EUR 500.000, valid 6 months after the expiration date of the licence, with irrevocable obligation to pay any amount the bookmaker is obliged to pay

#### **Premises License**

- Authorises the use of premises to provide **Class A** betting services
- payment of the relevant fee,
- Submission of form, with:
  - $\circ\,$  information and documents
  - written statement from the owner of the premises granting consent for the premises being used to provide Class A betting services

#### **Obligations of Holder of Premises License**

- display in a prominent location at premises:
  - $\circ$  the premises licence
  - a sign in Greek, Turkish and English that minors are prohibited from entering the premises
  - in Greek, Turkish and English, the terms and conditions under which betting services are provided
- Allow entry to members of the Cyprus Police and/or persons authorised by law, to check for compliance with the terms of the licence and the Law.

#### <u>Conducting Betting - Class A</u> (Physical)

- Betting slips format approved by the Authority
- Slips and any other document related to the provisions of betting services must be retained for a period of 5 years



- Conducting Betting Class B (Online)
- <u>Registration</u>
  - $\circ~$  Online application:
    - Age confirmation
    - $\circ$  ID Details
    - Home address
    - o Email address
    - confirmation of knowledge of terms of bet and way conducted, including amount he may be required to pay



- Player's account credited from the player's bank account or by:
  - credit cards, or
    debit cards, or
    electronic transfer, or
    electronic money, issued

by authorised EMI.

#### **E-sports**

- No legal definition
- Organised competitive video game play
- professional component: players and teams operating as businesses



#### **E-sports**

- Directive 4.2020 of the NBA: esports = "sports"
- Submission for approval by the Authority of the terms and conditions and a list of tournaments



#### ISP Obligation to Implement Blocking System

- Prevent users-customers from accessing providers of betting services without Class B licence, and:
  - $\circ\,$  slot machines
  - $\,\circ\,$  online casino games
  - $\circ$  Betting Exchanges
  - $\circ$  Spread Betting
  - $\circ$  Dog Racing

# ADDICTION

#### **Player Self-Protection Measures**

- determine the limit he may bet for a specific period
- determine the limit he may lose for a specific period
- determine the limit of time within which he may bet
- exempted from betting for a specific or indefinite time

- Single Integrated Casino Resort 15-year License granted in 2017 to 'Integrated Casino Resorts Cyprus Limited'
- 1 ICR and 4 satellite Casinos

#### **Regulated Matters**

- working times
- entry requirements
- exclusion orders Dispute resolution process
- Casino layout, gaming machines, equipment.
- Licensing of Casino employees and executives.
- Internal audits.
- Regulation and supervision of operations
- Offences
- Powers of supervision and investigation
- Taxation

#### **The Lotteries Law**

 any plan for the distribution of prizes by a raffle or by a way which depends on chance



#### **Permitted Lotteries**

- Government Lottery
  - The Lotteries Director
     Income from the sale of Government Lotteries deposited in the State
     Fixed Fund after deduction of monetary prizes distributed

#### Small Lotteries (ancillary to celebration events)

- All income from the celebration event, after the deduction of costs must be made available for purposes other than private gain
- lottery prizes not of monetary value
- Lottery tickets cannot be sold
- Opportunity of participating in lottery is not the only or the essential motive for attending the event



#### **Private Lotteries**

- Restricted for sale by organisers to:
  - Members of organisation not relevant to games of chance/ betting/ lotteries;
  - Persons who all work on the same premises;
  - Persons who all reside on the same premises

#### **Private Lotteries**

- Conditions:
  - income, after deduction of printing costs, allocated to the prizes (if participants are members of organisation, for prizes and/ or for the purposes of the organisation
  - no written announcement/ advertisement
  - price of every lottery ticket must be the same
  - $\circ~$  names and addresses of organisers
  - lottery ticket must be fully paid and nonrefundable
  - $\circ~$  no lottery ticket can be sent by post

#### **Competitions with Prizes**

- Prohibited
  - predicting outcome of future event, or past event the outcome of which is not yet known
- <u>Permitted</u>

 Competitions, the success of which depends on skill

#### **OPAP**

- The Certain Games of Chance Law
- OPAP CYPRUS since 1969
- Concession Contract between the government of the Republic of Cyprus and OPAP - Exclusive license issued by the National Betting Authority on 26/6/2024
- LOTTO, TZOKER, PROTO, KINO, SUPER 3, EXTRA 5, PROPO, PROPO GOAL
- OPAP CYPRUS: 202 betting shops
